IMPORTANT INFORMATION REGARDING COVERAGE FOR PERSONAL PROTECTIVE EQUIPMENT (PPE)

United Concordia is closely monitoring COVID-19 and its impact on the communities we serve. While the situation is constantly changing, one thing remains constant: our focus is on the health and well-being of our members, dentists, employers, producers, partners and our valued employees.

In an effort to keep our network dentists, their office staff, and our members safe, we will be allowing providers \$10 per patient visit for dates of service from 5/1/2020-6/30/2020 to help cover the costs associated with purchasing masks, sterilization procedures, and other CDC requirements resulting from COVID-19.

This coverage will apply to United Concordia administered business only, including: PPO commercial^{*}, Medicare Advantage, TRICARE Dental Program (TDP), Active Duty Dental Program (ADDP), Federal Employees Dental and Vision Insurance Program (FEDVIP), Gateway Health Medicare and Medicaid and our partnership business.^{**}

PPE Code:

• To align with ADA guidance, please use procedure code D1999- unspecified preventive procedure, by report.

Claims Submission:

• Claims must include procedure code D1999 to be eligible to receive payment for PPE.

Frequency limitations:

• D1999 can be used once per patient visit to cover the additional costs for PPE.

United Concordia will continue to assess the increased impacts of PPE due to COVID-19. We will be evaluating additional measures to assist your office during these difficult times, including a review of our fee schedules for potential adjustments in the coming months.
